Delivering the SDGs at the subnational level: opportunities and best-practices for regional governments

Summary

In the efforts of nations worldwide to achieve the Sustainable Development Goals (SDGs), the involvement and contribution of regional governments are fundamental. Considering regions, states and provinces have ongoing efforts, strategies and projects concerned with Sustainable Development, why and how these should incorporate the UN 2030 Agenda? This webinar thus envisages to present introductory paths and examples of the opportunities and actions regional governments may adopt to address the SDGs in each territory. Building on this online meeting, we would like to establish a community of practice to enable exchanges and mutual support in the implementation of the SDGs.

Background

The United Nations Sustainable Development Summit adopted the 2030 Agenda back in 2015, containing a set of 17 Sustainable Development Goals (SDGs) and 169 targets. The SDGs cover a broad range of themes aiming to balance the economic, social and environmental dimensions towards sustainable development. With the promise "to leave no one behind", the SDGs implementation requires action at all levels, and especially at the subnational level, based on the efforts of local and regional governments.

With clear direct competences on planning, legislation and decision-making over territories, regional governments are fundamental partners to the success of national efforts on the SDGs. Particularly, regional governments have a clear role in the provision of basic services, such as water and sanitation, health, education and food security, it becomes a necessary partner to achieve the related goals and targets.

Most subnational governments already have many policies and programs in place for the sustainable development, and several regional governments have already started to put in motion actions to pursue the implementation of the SDGs in their territories. The government of Wales, for example, took the lead as the first government ever to commit to the SDGs implementation through legal enforcement. The governments of Catalonia, Valencia, Sao Paulo, Flanders, Azuay or the Western Province of Sri Lanka have already started internal participatory processes to agree on the best strategies to contribute to the SDGs.

In 2016, nrg4SD carried several consultations with member regions to understand and identify priority areas and topics that should be considered to begin the implementation process of the SDGs. Particularly, these areas are connected to the establishment of the appropriate enabling environment and internal institutional arrangements for the implementation of 2030 Agenda by regional governments. Even before taking action for each of the specific 17 thematic SDGs, regional governments need to consider the organizational elements to enable this agenda, which includes:

- 1- Mainstreaming the SDGs: internal integration and organization
- 2- SDGs Subnational Strategies and Plans: priorities, needs and gaps
- 3- Multi-stakeholder partnerships: ownership, participation and accountability
- 4- Means of implementation: financing and capacity building
- 5- Multi-level governance: national, regional and local governments
- 6- Follow-up and review: monitoring and data disaggregation









All these elements are crucial for the localization of the SDGs, in terms of bringing this global agenda to the subnational level, where action and transformation takes place on the ground.

Objectives

The key objectives of this webinar are to highlight:

- Opportunities and challenges for regional governments to engage and contribute to the 2030 Agenda for Sustainable Development;
- Concrete cases of how regional governments consider and address the SDGs in their governments;
- The importance of collaboration, exchange and peer-review of these efforts in regional governments;
- The role of organizations as nrg4SD and ORU Fogar to support and assist members in the efforts towards the implementation, follow-up and review of the SDGs;
- Strategic alignment at the subnational level of the Agenda 2030 with the New Urban Agenda and other documents for sustainable development in order to generate synergy and catalyze the achievement of SDGs
- Multi-stakeholder and multilevel partnerships in terms of subnational actors and collaboration with national and local governments;
- A process to collect experiences and case-studies to be used as a reference publication for other governments and interested international actors on efforts of regional governments.
