# **Background**

The Fourth Financing for Development Conference (FfD4), scheduled for 30 June – 3 July 2025 in Seville, Spain, marks a critical opportunity to reflect on localized finance and review progress on the Addis Ababa Action Agenda as it reaches its 10-year anniversary. The conference will address emerging trends in development finance, advocate for reforms in the international financial system, and emphasize the vital role of local actors in achieving the Sustainable Development Goals (SDGs).

Transforming and localizing the SDGs requires investments from diverse sources, coordinated within a coherent policy framework, and strengthened by public-private collaboration. FfD4 must therefore draw on successful models for local development financing, showcasing scalable tools and approaches adaptable to various themes, regions, and governance levels and explore innovative financing instruments that





highlight the importance of localizing development finance and fostering public-private collaboration.

To this end, Rede ODS Brazil, in collaboration with the Local2030 Coalition as the UN Platform for SDG Localization, is organizing a webinar that brings together experts and practitioners from public and private sectors. This webinar will highlight the potential of localized development financing, the role of city governments and the application of innovative finance instruments drawn from the Brazilian experience with the implementation of the ground-breaking national legislation called the City Statute and its tools such as the urban operations, tradeable air rights, development rights auctions and others. The webinar will serve as a platform to showcase replicable experiences that may inspire local governments across the globe willing to pioneer local actions in driving sustainable urban development.

# **Objectives and outcomes**

- Highlight local efforts in sustainable financing, showcasing the benefits and potentials of territorial, multi-actor, and multi-level approaches to achieving the SDGs.
- Spotlight innovative financing mechanisms, amplify local successes, and advocate for increased role of local/municipal financing to advance the Addis Ababa Action Agenda.
- Develop a tangible report with key messages and policy recommendations based on concrete local practices and tools on localizing finance and promote sustainable cities.

- Public Sector Participants: Local government officials, regional/national government representatives, heads of local finance departments or treasurers, leaders from departments tied to key SDGs, such as housing, transport, education, environment, and health.

Camila Maleronka

**Camila Maleronka** is a seasonal urban planner specialized in housing, planning, and urban financing instruments with more than 25 years of experience. She holds a degree in Public Administration from the Getulio Vargas Foundation (FGV) and in Architecture and Urbanism from the

University of Sao Paulo. A master's degree in Housing from the Technological Research Institute of Sao Paulo (IPT) and a PhD in Urbanism from the University of Sao Paulo (USP). She recently completed postdoctoral research at Federal University of the State of Rio de Janeiro (UFF). She is currently a professor of urbanism at Maua Institute of Technology (IMT) and INSPER. Between 2010 and 2013, she was Manager of the Economic Studies Department at SP Urbanismo, a company linked to the Municipal Secretariat of Urbanism of the city of São Paulo. From 2013 to 2018, she worked for P3urb, a company focused on real estate projects based on public-private partnerships. Since 2010, she is an associated fellow of the Lincoln Institute of Land Policy working on training programs and technical assistance focusing on land management, land value capture, and financing instruments. She is a consultant for the Inter-American Development Bank (IDB) and the World Bank on urban planning issues and author of various articles, reports and key publications. She is the lead author of the IDB's publication on Urban Operations in Sao Paulo

**Osmar Lima** is an experienced manager who is currently Municipal Secretary for Economic Development of the City of Rio de Janeiro and President of the Participation and Investment Company of the Municipality of Rio de Janeiro (CCPar). Before joining the municipal

government of Rio de Janeiro, he worked as a senior manager at the National Economic and Social Development Bank of Brazil (BNDES) for more than a decade as head of several departments, namely the Public Real Estate Asset Department, the Public Private Partnership Department, and the Municipal Projects Department in the Privatization and Project Structuring Area. Amongst several projects, he was responsible for municipal operations, such as the bank's Public Lighting PPP Structuring Program. He has also worked as a credit analyst in the Industrial Area and as a private equity investment manager. He acquired his degree of Engineering from the Federal University of Rio de Janeiro and a master degree in Production Engineering, Management and Innovation from the same university, with Specialization in system engineering at the University of Virgina, USA. He is a certified CFA Institute Charter holder. He is also a certified Real Estate Law specialist by Getulio Vargas Foundation (FGV).





Claudio Acioly

Claudio Acioly is an architect and urban planner, a development practitioner with more than 40 years of experience. He has worked in more than 45 countries. Acioly started his career as social housing and slum

upgrading expert of the Government of Brasilia (1983-1987) followed by an overseas post for the Dutch Government as chief architect of the neighborhood upgrading programme in Bissau (1989-1992). He worked internationally as senior project manager and lead housing and land expert with the Rotterdam-based Institute for Housing and Urban Development Studies-IHS (1993-2008) where he further enhanced his experience in participatory action planning, training, capacity building, moderation of policy dialogues and institutional strengthening in various countries before joining UN-Habitat (2008-2019) as chief Housing Policy, coordinator of the United Nations Housing Rights Program and the Advisory Group on Forced Evictions to the Executive Director of UN-Habitat – AGFE and head of Capacity Building and Training. He has acquired a solid experience in design and delivery of the entire cycle of professional training, post-graduation courses and educational programmes in addition to moderation and facilitation of inter-governmental dialogues, facilitation of public debates, staff retreats and moderation of large debates in global forums like WUF, Habitat III, UIA, LAC Housing Forums and World Habitat Day. He worked as consultant for the World Bank, IFC, UNECE, UNEP, UN-Habitat, DGIS, Cordaid, GIZ and national and local governments across the globe and published widely on various topics.
